**FULL OFFICIAL RULES**  
**DoubleTree by Hilton Naha Shuri Castle “Traveling Chocolate Chip Cookie”**

**ELIGIBILITY:** Only legal residents of Japan, who are 18 years of age or older at time of entry are eligible to enter. Not open to employees, officers or directors, or to members of the immediate family or household (whether related or not) of any employees, officers, or directors of Ryukyu Hotel Resort Naha Co.,Ltd trading as DoubleTree by Hilton Naha Shuri Castle (“**Sponsor**”), or any of its parents, subsidiaries, affiliates, franchisees, or any advertising, promotion or other agencies or suppliers involved in this Campaign (collectively, the “**Campaign Entities**”). Eligibility may be verified at any time. **CAMPAIGN PERIOD:** The Campaign begins on Friday, 22 May, 2026 at 12:00 PM Japan Standard Time (“**JST**”) and ends on Friday, 29 May, 2026 at 11:59:59 PM (JST) (“**Campaign Period**”). The Sponsor’s database computer is the official timekeeping device for the Campaign.

**HOW TO ENTER:** To participate, entrants must have Internet access and a valid Instagram account. During the Campaign Period, entrants complete the following steps:

- (1) Visit the Sponsor’s official Instagram account (<https://www.instagram.com/doubletreeshuri>) (“**Sponsor’s Page**”) and be a follower of the Sponsor’s Page. Following the Sponsor’s Page is free;
- (2) ‘Like’ and leave a comment on the Campaign post on the Sponsor’s Page describing what type of experience they would like to have during their hotel stay.
